WHAT IS PERSONAL INFORMATION

Personal information is information about an individual who can be identified, or whose identity could be reasonably ascertained, from the information.

WHAT WE COLLECT

We may collect the following information:

- Name
- Contact information including email address
- Demographic information such as postcode
- Other information relevant to customer orders

WHY WE COLLECT INFORMATION

To deliver and enhance the services offered by Cambridge Gymnastics & Trampoline Club, certain personal information is collected.

HOW WE COLLECT INFORMATION

Cambridge Gymnastics & Trampoline Club collects personal information from you that you volunteer when:

- You register to become a member of our club
- You purchase merchandise from us
- You request information from us
- You provide information to one of our staff

WHAT WE DO WITH THE INFORMATION WE GATHER

Only information that is necessary for us to carry out our primary purpose of providing services relating to membership, training, events and merchandise is collected.

We require this information to understand your needs and provide you with a better service, and in particular for the following reasons:

- Provide the services you require
- Internal accounting and administration
- Regulatory reporting and compliance
- To improve our products and services
- We may periodically send emails containing our newsletter or other club information, using the email address which you have provided
- Updating you via newsletters or emails of club news and information

STORAGE AND SECURITY OF PERSONAL INFORMATION

Cambridge Gymnastics & Trampoline Club stores personal information on computer databases and we are committed to ensuring that your information is secure. In order to prevent loss, unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.
